

# The Ansgar Danish Lutheran Church MINUTES OF THE ANNUAL CONGREGATIONAL MEETING March 1, 2020 at 12:30 p.m.

24 registered voting members were present. A total of 55 individuals had registered as voting members.

The meeting was called to order at 12:30 p.m. by President Valerie Sørensen who recognized a quorum of voting members.

- 1. **Opening hymn** no. 259 "Day by Day" and opening prayer by Pastor Lasse Hultberg.
- 2. **Election of chairperson.** Nominations from the floor. The Board nominated Jeanna Baty. Johanne Nicolajsen seconded. Jeanna Baty accepted and was elected by acclamation.
- 3. Approval of agenda. No questions or objections arose. The agenda was adopted as printed.
- 4. **The minutes of the Annual Congregational Meeting on February 24, 2019.** There were no questions or corrections. The minutes were for information only and accepted as presented.
- Business arising from the Annual Congregational Meeting on February 24, 2019.
   a. Presentation of Revised Constitution & By-laws. Approved on February 24, 2019. Chairperson Jeanna Baty noted that the Revised Constitution & By-laws were now available to members.

# 6. Reports presented in the printed ACM handout.

**Danish Women's Club**. The report was prepared by Jeanna Baty, and the financial statement was prepared by Bent Skousbøl.

Men's Breakfast. The report was prepared by Kaj Nicolajsen.

**Camp Kuriakos**. The printed report from Camp Kuriakos to Congregational Annual Meetings in 2018 had been prepared by Rev. Art Weiss, Executive Director of Sylvan Lake Lutheran Bible Camp Association. **Hyggeklubben.** The report was prepared by Randi Mark. **Coffee Fund**. The report was prepared by Birgit Wildenhoff.

# Motion: Kirsten Thorup moved to accept the reports as printed. Randi Mark seconded. Motion was carried.

- 7. Pastor's Report. The report for the year 2019 was accepted as prepared and read by Pastor Lasse Hultberg. Question from the floor: Jeanna Baty asked how many people had attended the Kuriakos Camp in 2019. Pastor Lasse Hultberg replied that 40-45 individuals had attended.
- 8. **President's Report.** The report for the year 2019 was accepted as prepared and read by Valerie Sorensen. No questions arose.
- **9. Treasurer's Report.** The following 4 statements as printed in the ACM handout were presented as prepared by Treasurer Bent Skousbøl:
  - Balance Sheet
  - Statement and Income and Disbursements January 01, 2019 to December 31, 2019
  - Cash Flow Statement
  - Statistical Reports Church activities 2019. For information only.

The treasurer explained the details of the balance sheet and the current assets. He also pointed out that fixed assets – such as land, buildings and shares – cannot be released until sold. Concerning the shares, their market value is less than the book value at this point, but the Church receives \$600 in dividends quarterly regardless of the market value.

# Questions from the floor:

- Jeanna Baty asked if she was correct in her understanding that incoming donations are not sufficient to cover expenses, although the Board strives to reduce costs and expenses. The Treasurer confirmed that Jeanna Baty was correct in her understanding.
- Jeanna Baty also inquired about the deficit for 2018 and 2019. The Treasurer explained that the deficit is a cumulative loss.

# *Motion: Alice Nickel moved to accept the Treasurer's Report 2019. Elinor Gleerup seconded. The motion was carried.*

# Proposed Budget for January 1, 2020 – December 31

The Treasurer presented the 2020 budget and the yearly comparisons. He explained how the Congregation's acceptance of the proposed budget is connected to the Church's income/donations, i.e., once the budget has been accepted, the membership has at the same time committed itself to raising the funds.

Acceptance of the proposed budget becomes a congregational commitment, and to this effect the Board has initiated a phone campaign in order to encourage members to donate regularly. Without regular support, the Church cannot continue. Moreover, we cannot continue to rely on a handful of generous donors to carry the financial burden. The Treasurer added that if 300 members were to donate \$50 monthly, the Church's operational costs would be covered.

Finally, the Treasurer reminded the members that Ansgar Church is committed to not only providing spiritual guidance and a place for worship but also to upholding cultural traditions of Danish/Scandinavian origin.

### Comment from the floor:

Valerie Sørensen pointed out that the item in the budget "Provision for Congregation Assistance Fund" of \$2,000 is not a new item per se. A discretionary fund has always been available to the Pastors at Ansgar Church; only now the fund has been budgeted for and given a special name.

# Motion: Jens Woller moved to accept the Proposed Budget 2020. Kirsten Olsen seconded. The motion was carried.

### 14. New Business.

# a. Financial planning for the required cash flow needed for the operation of the Church on a monthly basis.

Treasurer Bent Skousbøl spoke to the issue of the required cash flow needed for the operation of the Church. First, he mentioned that the online donation feature on the Church's website is now up and running and added that so far only one individual has made a donation through the website.

The Board is trying to make the payment options as user-friendly as possible. For example, reoccurring donations can be made on Visa and Mastercard; the payment date has been set for the 28th of each month. As far as security is concerned, all personal information needed for the set-up will be destroyed after the Treasurer has entered it on Moneris (the payment processor). At this point, only 13 individuals have opted to donate regularly by credit card.

Collections at Sunday services, he explained, are not meant to pay for monthly expenses. Instead, utilities, insurance and other regular expenses needed to run the Church should be covered by regular monthly donations. To this effect he encouraged members to help spreading the message about donating on a regular basis.

The Treasurer reminded the members once again that Ansgar Church is first and foremost committed to its spiritual mission but also to upholding cultural traditions of Danish / Scandinavian origin.

### Questions and comments from the floor:

- Valerie Sørensen asked if it is possible to make regular donations with a credit card on two different dates each month. Bent Skousbøl confirmed that it is possible to choose payment dates other than the 28th of the month, but that the process is easier for him if all donations are processed on the same day.
- Jeanna Baty commented that she is using the credit card option and finds it very convenient.
- Kaj Nicolajsen asked whether the Board has names, addresses and phone numbers for 300 members available and has organized an appeal for donations. Kaj Nicolajsen referred to the Treasurer's earlier comment in connection with the proposed budget for 2020 – "that if 300 members were to donate \$50 monthly, the Church's operational costs would be covered". Bent Skousbøl replied that a phone committee has been set up. Mette Rasmussen added that lists along with a script have been created.
- Johanne Nicolajsen wanted to know if callers would appeal to both spouses in cases where spouses donate as a family unit. Bent Skousbøl replied that both spouses would be consulted.
- Jens Woller enquired about the Church's insurance and whether is would be possible to get a better rate. Bent Skousbøl explained that the board has investigated another company that specializes in church insurance, and while their rate is better, their coverage is not. We need to cover two buildings and all the improvements.
- Mette Rasmussen commented on the importance of maintaining the Danish rituals, such as baptisms, weddings, confirmations and funerals. She also pointed out that the monthly donations of \$50 as suggested by the Treasurer would be equivalent to what taxpayers in Denmark pay in church taxes.
- Jeanna Baty commented on the fact that some people have become members of other churches; however, they may still want to donate and should be encouraged to do so.
- Mette Rasmussen suggested that we should invite members from the congregation to sit on a fundraising committee.

# 16. Coffee Break.

Prior to the coffee break, Jeanna Baty reminded the members that volunteers are still needed for the Sunday School, Church Owls, Church lunch, Kuriakos as well as the Ansgar Singers choir.

**17. Reading and Approval of the Minutes of the Annual Congregational Meeting of March 1, 2020**. The minutes were taken and read by Marina Allemano.

# Danish Women's Club Report to the Annual Meeting 2020

The Danish Women's Group is primarily a group which raises funds to support the Church. The women who participate in it, also enjoy the social benefits of working together in this worthy enterprise! There is little to report for the year 2020, however, due to the COVID-19 Pandemic. At our January meeting, we primarily reviewed the success of the Christmas Bazaar the previous December, where we had raised \$8,578.20 for the Church. The February 22<sup>nd</sup> meeting focused completely on updating our plans for the Spring Dinner (and non-profit Fun Bingo) event planned for late April 2020. Little did we know at that time, that would be our last meeting for a year!

The only event that we were able to participate in this year was thanks in large part to Alice Nickel. She had the idea for an **on-line Christmas Bake Sale**, and with the help of members of the Women's Group and many other fine bakers, she co-ordinated the first Danish Bake Sale, entirely on-line. We knew how popular the Danish treats usually are, with an eager line of shoppers waiting for the Bake Table to open every Christmas Bazaar, but we did not anticipate the overwhelming response we had this year! With a simple order-in-advance and easy pay-on-line system, set up by Alice in co-operation with Ansgar Treasurer Bent Skousbøl, we filled all the initial orders…but they just kept coming. We had many more orders for the six or seven items offered this year than ever before. Thanks to all the bakers and "leverpostej" makers…and to those other half dozen or so bakers, who just kept at it until all orders were filled!!

So, this year, for the only event we could sponsor, we raised **\$3,971.00 for our Church.... more than a thousand dollars over the previous year**. We are an impressive volunteer crowd when called on! A big "thanks" to so many who made this a success and for making available to us all, the rare Danish Christmas treats we all enjoy so much at Christmas!

Over the remainder of the year, we have tried to keep in touch through distanced visits and phone calls whenever we could. So far, we are all well and managing, but we are certainly looking forward to returning to our regular monthly meetings, as soon as we are able.

#### 2020 in REVIEW:

Despite unusual circumstances, we have continued to connect with our community. Looking back, this has been a successful year full of new programs.

- On ZOOM, we hosted the Women's Retreat, two Prime Time Retreats, Leaders In Training and our Staff Leadership Development Program, QUACK (Quest Using a Computer at Kuriakos, an interactive Bible Study for kids), Summer's Acts Bible Study, October's Joy Bible Study, and November's Creation Care Bible Study
- Recorded videos throughout the summer. Monday Bible Study, Tuesday Coordinator's Choice, Wilderness Wednesday, Fun Craft Friday.
- Regular Campfire gatherings on Zoom and recorded on YouTube.
- Undertook many facility rejuvenation projects (interior painting through most of our lodges, waterfront repairs, staining of outdoor railings and equipment).

We have experienced numerous changes to our staff team, in particular the passing of Rudy Lange, our Property Manager. Madi, our Hospitality Manager, and Gail, our Bookkeeper and Housekeeper, were also laid off due to the closure of our facilities.

Kelly Craig and his wife Anissa have joined our team as Property Manager. Our Association continues to be served by Kendra as Program Director, Paul as Assistant Director, and Rev. Art as Executive Director.

2020 Membership Partners - 21 (up from 12 last year!) Members - 8 Many congregations provide financial support as part of their annual budgets or through special gifts. Program revenue covers roughly 40% of the cost of hosting campers. This is a wonderful opportunity to bless kids and families in need, giving them the best week of their year. If your congregation is able to make a donation or finance a local Campership Fund (\$23k in 2019), please contact the office.

FINANCES: The tentative budget for 2021 proposes an annual operational revenue of \$523.165.

As with other organizations, COVID-19 has had severe impacts on our budget (as reflected in the revenue below). Fortunately, a combination of government loans and grants, plus careful management, staffing changes, and the generosity of our community, has stabilized our operations. However, 2021 will continue to be challenging as we work toward re-opening our programs and facilities.

# President's Report to the Annual Meeting 2020

What a year 2020 was. It began normally enough but big changes came our way in the spring with the beginning of the Covid-19 global pandemic. Like the rest of the world, we were unprepared for the array of reconfigurations we would have to learn to make.

Ansgar Church held a beautiful Candlemas Service with musical and choral performances late on the afternoon of February 2. Fastelavn was well attended with 80 participants, many wearing fanciful costumes. Boller were consumed, the barrel was smashed and sweet treats were shared. The Board, together with the Women's group was in the midst of preparing for Spring Supper and Bingo when everything exploded into uncertainty. All the rest of our usual fellowship gatherings and events for 2020 were cancelled, with the exception of a "pandemic-safe" version of the Christmas bake sale. The event was a great success and I'm truly grateful to Alice & Harry Nickel, Kirsten Olsen & Jeanna Baty, and Bent Skousbøl and all their hardworking helpers and bakers. It's amazing what a determined group can accomplish. Together we raised over \$3000.00 thanks to your support.

We had a couple of maintenance/improvement projects on the go and the yard, deck, and fencing were completed. A problem with drainage was resolved by replacing some eavestroughs. No other projects were begun and only necessary maintenance is being done at the church.

Pastor Lasse has had quite an increase in the need for his time. Many more members than usual required his assistance with uncertainties, illness and death, and spiritual guidance in 2020. It was challenging for him to personally meet with people at times because of restrictions. Ansgar Church has a capacity of about 100 people during normal times and we were limited to only 15 several times this year. It's an impossibility for the Board to choose attendees and holding an attendance lottery was unsavoury to us and we opted to close entirely for those periods. It was not an easy decision to make. Pastor Lasse live-streams Services when we are allowed to be open and puts together a pre-recorded Service available through our website and Facebook when we are not so that everyone can still attend virtually. Those are new skills for Pastor Lasse and we're both impressed with his willingness to learn and grateful for his accomplishments. I thank him for his extra efforts this year and my gratitude extends to his family for their unwavering support.

It has been a challenging year financially. It isn't easy to be always asking for financial donations from the membership, but it is necessary. Our church requires a certain amount of money to continue and many of our people are under their own strain this year. Together we pitched in what we could and our church lives on to meet our needs. Please sign up for a monthly giving plan.

The Church Board has had to think on our feet this year. We've had to be open-minded about solutions and be accommodating in new ways. We are just ordinary people, people like you. None of us have special training in how-to-be-a-Board-member, we all learn as we go. Some of us have years of board experience, some of us are new to it. Some of us know a bit about this and others know a bit about that and together we can figure out many things. We are restricted in our ability to meet in-person and, when allowed, we've held meetings in the church by spreading out and giving ourselves the required distancing while wearing masks. We've had to learn through trial and error how to meet virtually. We are making it work to the best of our ability.

I must express my gratitude to my fellow board members for their willingness to do everything necessary to bring Ansgar Church into line with the restrictions imposed. Without their help, knowledge, and ingenuity, this job could have been so much more difficult. Most of the board members are repeat volunteers but even the newest of us jumped in feet-first and did what needed to be done. I am privileged to have worked with a group that has a wealth of experience and spirit of whole-hearted co-operation. I thank you all.

To the congregation, I appreciate your trust and support through this trying period and thank you for all you have done.

# 2.3 ELECTION TO THE CHURCH BOARD OF DIRECTORS

# 2.2 Qualifications

A member shall be qualified to be on the Church Board of Directors if:

- a) That person is an active Member who has been a Member of the Church for at least six months
- b) that person is over the age of 18 years
- c) that person does not have a status of a bankrupt; and
- d) that person is mentally competent

# 2.3.1. Nominations

Persons possessing the qualifications set out in Article 2.2 can be nominated for election to the Church Board of Directors.

# 2.3.3. Additional Nominations

Nominations for candidates for a position on the Church Board of Directors can also be made from the floor at the Annual General Meeting by any active Member, providing that any candidate, so nominated, agrees to let his or her name stand for a position on the Church Board of Directors. These nominations can be made in addition to a slate of candidates made to the Nominations Committee.

# 2.3.4 Nomination and Election of the President

The President is elected by a simple majority vote, using ballot procedure. If the President is elected from the existing Church Board of Directors, another Member is elected to the Board as a substitute in this position for the one year he/she is President. If a substitute for the President is required, he who received the 4<sup>th</sup> highest number of votes is elected to that position.

# 2.3.5 Nomination of Remaining Board Members

In electing the other three Members, three names can be written on the ballot. The three who receive the most votes are elected.

# 2.4 TERM OF OFFICE

Vacant Positions

The President is elected for a one-year term at each Annual Congregational Meeting; the remaining nine Board Members are elected for a three-year term in such a manner that three are elected each year. The Pastor is a permanent Member of the Board.

4 board members – each for a 3-year term Feb	ruary 2024
1 auditor – 2-year term Feb	ruary 2023
1 Pastoral Selection Committee member – 3-year term Feb	ruary 2024
